## 2. Purpose of Introducing the Senior Executive Officer System

We transitioned to a company with an audit committee in November 2022 to strengthen the supervisory function of the Board of Directors while promoting faster decision-making and execution through delegated authority to business promotion teams.

We have now introduced the Senior Executive Officer system to further clarify the responsibilities of executive officers and foster early awareness among potential future directors, aiming to enhance corporate governance and improve corporate value.

## 3. Overview of the Senior Executive Officer System

- (1) Senior Executive Officers are selected by the President and Representative Director based not only on performance contributions but also on their comprehensive perspectives, management judgment, character, and insight as potential future directors. The President and Representative Director create a proposal for candidates for Senior Executive Officers from among the executive officers, which is then decided upon by the Board of Directors following consultation with the Nomination and Compensation Committee.
- (2) Senior Executive Officers have decision-making authority raised to the level of directors.
- (3) The term of Senior Executive Officers are one year.
